

Terms of use of the game

Mazuri GameFi

1. INTRODUCTION

Mazuri GameFi is a free online game in the GameFi genre and with the Play to Earn model (has separate paid services) - hereinafter referred to as "Game" .

These Mazuri GameFi Terms of Use , together with any additional terms and policies included herein , constitute a legally binding agreement (collectively, the "Terms" or "Terms of Use") made between you personally and Mazuri GameFi ("Terms" or "Terms of Use"). By agreeing to these Terms, you (an individual who has expressed a desire to use Our Services) and Mazuri GameFi s.r.o., registered in the Czech Republic, reg . No.: 144 42 957 (" Mazuri GameFi " , "we" , "us" or "our") agree to fully accept and be bound by these Terms in relation to your access and use of the website www.mazuri.io (" Site") and one or more Mazuri GameFi Applications ("App"), as well as any other media forms , media channels , websites or mobile applications available on or on behalf of Mazuri GameFi or otherwise related thereto (collectively with the Site) as well as the Application and any Smart Contracts or other software or services provided by Us , the "Services"). Services include any use of the Mazuri GameFi game (including downloadable software and/or online access to the Game) as well as a distributed application of Mazuri GameFi utility tokens operating on one or more blockchain networks , which may include the Ethereum network or other ("Blockchains") using smart contracts (each a "Smart Contract ") that interact with or enable the use of MZR (Mazuri GameFi Utility Tokens) . The Services also allow users to use or interact with smart contracts involving other digital assets , such as other utility tokens , in-game coins, NFTs, in-game land , in-game real estate, in-game items and skills ("Digital Assets"). These Digital Assets can be visualized using the Mazuri GameFi Services or other third party services.

The Services are not intended for distribution to any person or entity in any jurisdiction or country where such distribution or use would be contrary to law or regulation or which would subject us to any registration requirement or other regulation within such jurisdiction or country . 2. OUR SERVICES

a. General information .

- Who can play

Any owner of a Personal Computer with an operating system other than Mac OS who is over 18 years of age .

- Is there a free part of the game?

Mazuri GameFi is a game that can be played completely free of charge .

- What is paid in the game and how ?

Mazuri GameFi allows you to purchase in-game properties, upgrades, and other in-game items. They can be purchased on the game Marketplace for the MZR token.

- In Mazuri GameFi you can invite friends , play in pairs , develop skills , receive bonuses , sell, buy real estate , participate in tournaments , complete missions, etc.

After the player gets comfortable with his shots, he will have three game modes to choose from :

- Ranked Battles (Rating). To participate in ranked battles and tournaments, the player must leave his apartment and go down to the arena by going through the EXIT door in his apartment . There the player can start selecting opponents with the " U " key . When an opponent is found , players will have the opportunity to bet their tokens on themselves , and if they agree on a "BET" - the winning player will take the loser's tokens .

- Tournament Battles . "T" key . Players can sign up for tournaments and make a tournament contribution , which goes into the prize pool . After the tournament, rewards are distributed in relation to the place the player took .

- Missions (Expansions). " N " key . The player can do a speed run in the story mission . You can also make a race by putting a token into the prize fund . Thus, the speed at which the player clears the mission from opponents will be displayed in the Weekly / Monthly / Quarterly prize fund , which will be distributed among the leaders in accordance with which fund the player qualified for due to the speed of his race .

- What winnings can be in the game . Rules for receiving them:

Players who win a tournament or have a high rank in the leaderboard for completing missions receive MZR tokens from prize pools formed by contributions from all other players who participated in a paid race in a mission or tournament .

- How the tournaments are held:

Weekly tournaments take place on Saturdays . Four 1v1 tournaments every Saturday . And four tournaments 2 on 2. First 1 on 1, then 2 on 2 and thus they alternate . Players can track the timing of tournaments in the game. The tournament schedule may change at the discretion of the game administration.

The Services include an online platform through which users can view , offer to purchase and purchase Digital Assets that can be used and deployed in MAZURI game available through the Services . Users of the Services may have the ability to mint certain Digital Assets as non-fungible tokens (“ NFTs ”) on blockchains. To access certain Services , including to purchase any Digital Assets , the user must connect their own compatible digital wallet to the Services .

Minting of digital assets . By creating a Digital Asset as an NFT, you agree to comply with any terms , including licenses or payment rights , that are embedded or otherwise included in any such Digital Asset . Terms of use of digital assets .
